 - 8°C to 25°C: permitted exposure up to 24 hours* (not recommended storage)
- **Punctured:** 2°C to 25°C: use vaccine within 24 hours* of first puncture

* If the vial has been kept out of the fridge, it can be returned but the time kept above 8°C needs to be tracked. Total time the vial is kept above 8°C (punctured or unpunctured) is cumulative and cannot exceed 24 hours.



HANDLING:

- DO NOT DILUTE
- Gently SWIRL before withdrawing each dose; do not shake
- Can be handled in room light conditions

- White to off-white dispersion—may contain white or translucent particles
- NO foreign particulate matter/discolouration
