Injectable Vaccines with Diluents

- This list includes injectable vaccines that Saskatchewan pharmacists with advanced method certification may administer (does not include vaccines indicated for children <5 years old).
- Always check expiration dates on vaccines and diluents (and needles and syringes if applicable).
- ADMINISTER VACCINES PROMPTLY AFTER RECONSTITUTION. Delays between reconstitution and administration are NOT recommended. However, some vaccines have stability information if not administered immediately.
- Only use diluents provided by the manufacturer. Diluents are prepared by the manufacturer specifically for each vaccine.
- DO NOT freeze diluents or reconstituted vaccines.
